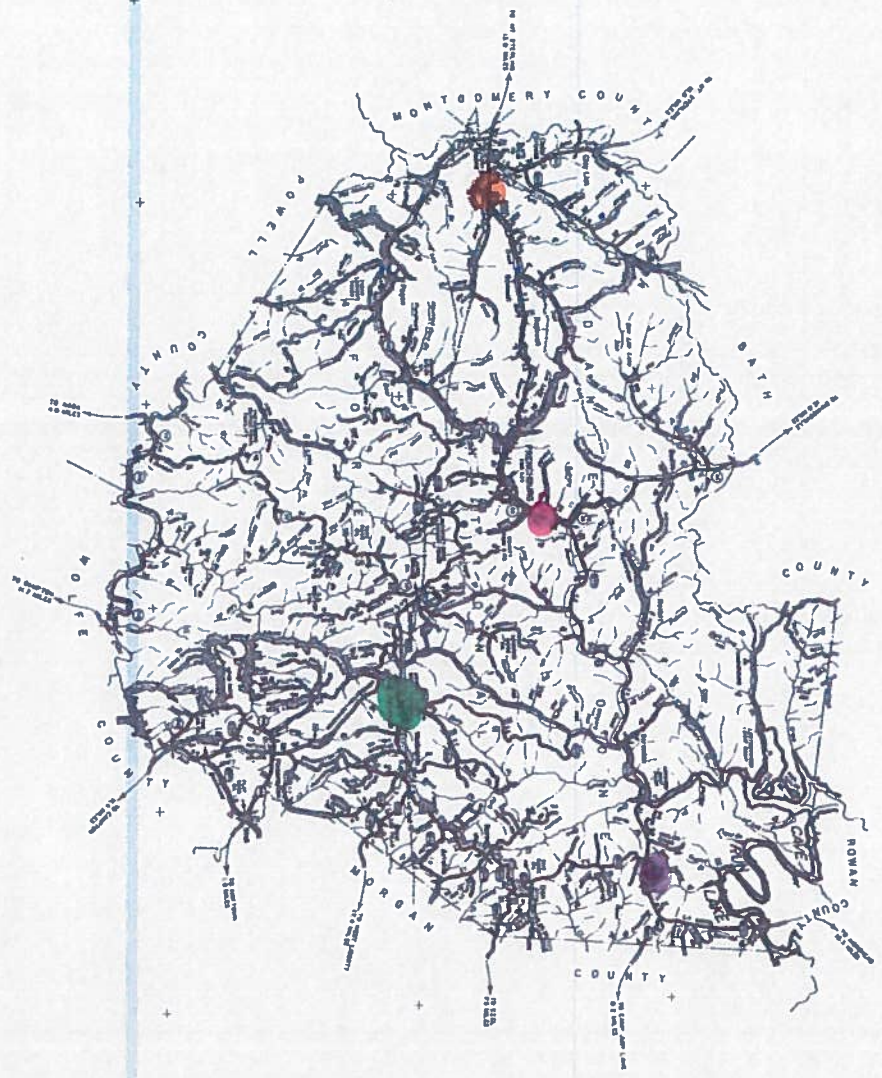


Dear Kentucky State Board of Elections,

I am writing to give you a better description of how voting on Election Day and Absentee Voting will be conducted.

Absentee voting will be located at the Clark Energy Building. This is located in the heart of our city. We will provide 4 Express Votes and 1 DS 200.

All other precincts will remain in the same locations as previous elections. The only difference is we will allow them to convert from a precinct to a Vote Center. This will allow any voter to go to any Vote Center and vote in their precinct. We have several in our community that work out of town and will actually have to pass three voting locations because we were limited by precinct. By doing the transition, it will allow that voter to stop at any of those locations. This will provide a more accessible way to vote and I believe voting numbers will increase.
