

Pulaski County was formed in 1799. It is located in the Pennyrile region of the state.

In 2020 the county population was 65,034 in a land area of 661 square miles, an average of 98.8 people per square mile. The county seat is Somerset. Its population in 2020 was

11,924 persons. There are four other incorporated cities in Pulaski County; Burnside (843) Science Hill, (696), Ferguson (886) and Eubank (313)



The county has 56 precincts, with 50,114 registered voters as of 1/15/2022.

There are 10,543 democrats, 35,435 republicans, and 4,136 designated as others.

Due to the size of the county and the disparity between the two parties, the County Board of Elections (CBE) wishes to remain with the voting centers rather return to the pre-pandemic precinct voting, due to the difficulties in sufficiently staffing the precincts.

We feel that the voting centers are better in that we have the best of the workers, and they are able to pool their knowledge to prevent the small mistakes that plague the elections every year. It also allows the precinct workers to vote the awaiting voters while handling the problem voters on the side.

The plan is to retain six of the voting centers used in 2020.

They are;

- 1) Science Hill Elementary Gymnasium
- 2) Nancy Elementary Gymnasium
- 3) Old Shopville Gymnasium
- 4) The Hal Rogers Regional Fire Training Center,
- 5) Rocky Hollow Recreational Center in Somerset,
- 6) The South Kentucky RECC Community Room on Parkers Mill Road.

We plan on moving the **Southwestern Voting Center** to the **7) Gymnasium at Oak Hill Baptist Church**. We were unable to communicate with the voting equipment using the MiFi system and instead had to use the school's less secure ISP at the school.

We expect the Gymnasium will have better MiFi reception as this is a former precinct location and we have not had these problems in the past.

We have also eliminated the Southern Middle School location, as it is less than 2000 feet from the **South Kentucky RECC Community Room**.

We would like to have voting at three sites for all the available days.

They are

Hal Rogers Regional Fire Training Center (4), Rocky Hollow Recreational Center (5), and South Kentucky RECC Community Room (6).

We plan on offering voting in all precincts at each of these locations.

Due to their rural location and distance from Somerset, we would like to open the **Old Shopville Gymnasium (3)** and the **Nancy Elementary Gymnasium (2)** for early voting as well, however we do not wish to interfere with the schools on the other days so want to limit voting for Saturdays only.

There will be a limited number of precincts available at these precincts.

Old Shopville Gymnasium (3) will have **6 precincts** voting there, with **3,745 voters**

Nancy Elementary Gymnasium (2) will have **7 precincts** voting there, with **4,258 voters**

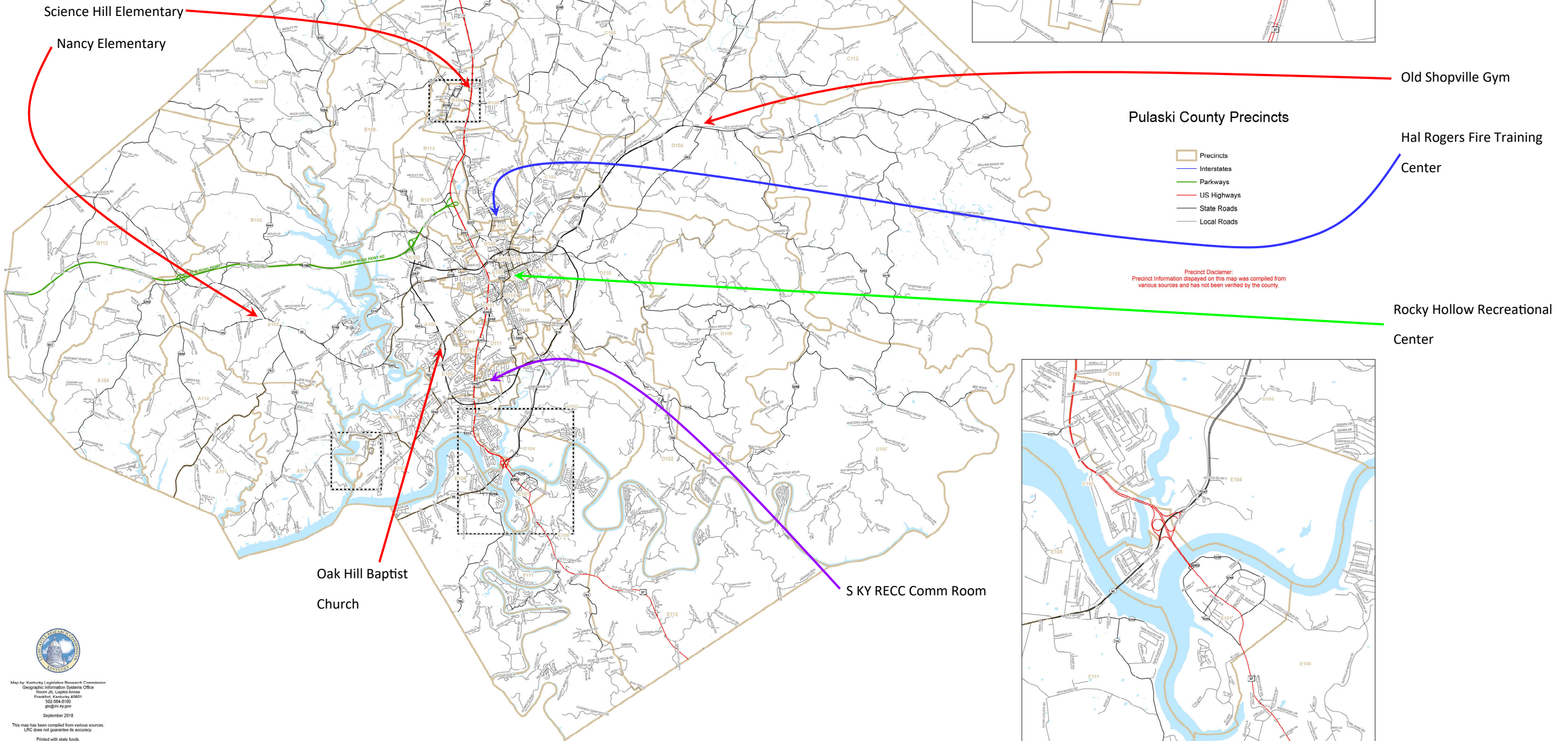
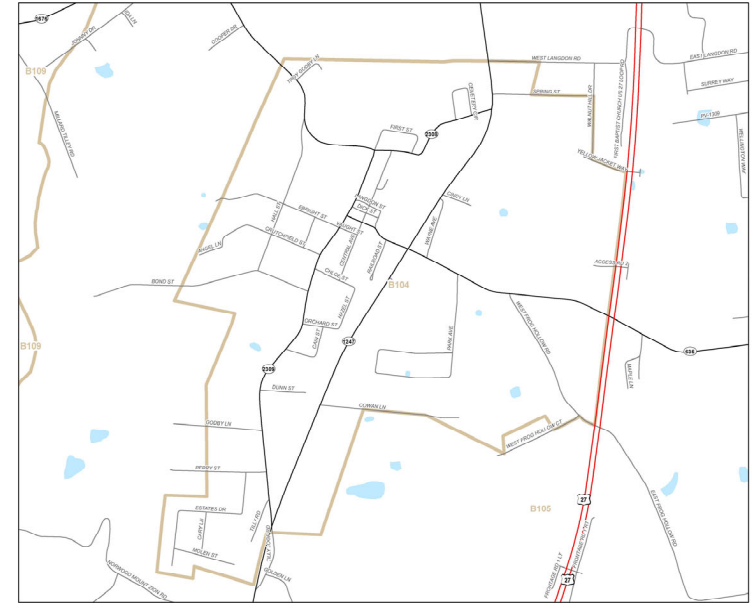
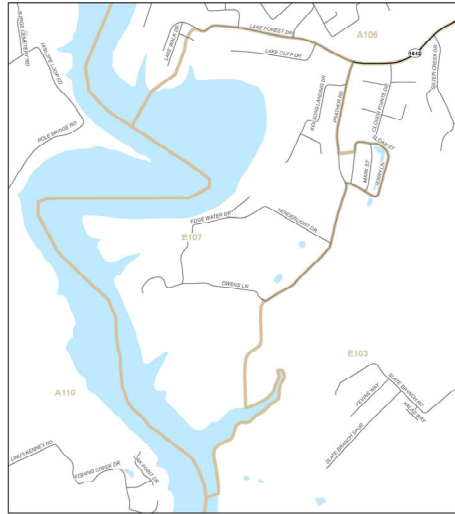

The voters of Pulaski County seemed to accept the early voting, as we voted 31,707 in November 2020, with 5,640 (17.7%) voting on election day. 82.3% of the total (26,067) voted early, by mail (6,009-19%) or in person (20,058-63.3%) voters. We realize that it is impossible to vote this level again, given the limited number of early voting days. We expect to vote 14,000 to 18,000 in the upcoming primary and as long as we can vote 2,500 on each early voting day, and 1,500 to 2,500 voters by mail, we would only have 8,000 to 9,000 on election day, or 1,142 -1,285 per voting center on election day. The voting centers should be able to handle this load with ease.

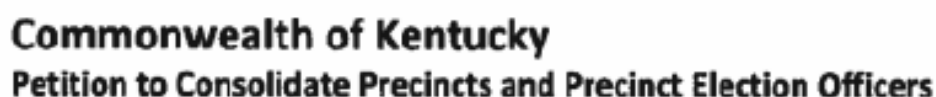
