Re: **IMPORTANT UPDATES REGARDING ROSTERS**

On October 14, a Franklin County Circuit Judge granted the Kentucky Democratic Party's Motion for Injunctive Relief regarding the list of inactive voters and ordered the State Board of Elections to return all voters to one (1) Master Voter List and place an asterisk by the voter's names who have been designated as inactive. Attached to this memorandum is a sample of how the rosters will look. The Electronic Poll Books will have an asterisk by the voter's name as well and a sample is attached.

Please instruct your Precinct Election Officers to perform their duties as they have been done in past elections: Confirm the voter's identity and current address (KRS 117.225). If their address is the same, they will sign the electronic poll book or the paper Precinct Roster. If the address has changed, follow the same procedure to update the voter that the County Clerks have done in the past:

Call the County Clerk to confirm the precinct of the voter. If:

- (a) the new address keeps the voter in the same precinct, the voter updates current address by making an address change on a Voter Registration Card. Have voter sign the Precinct Roster.
- (b) the new address moves the voter to a new precinct within the county, the voter completes the Oath of Voter, and signs the Supplemental Precinct Signature Roster. [KRS 116.025(3), KRS 116.025(4), KRS 116.085(2), KRS 116.085(3)]
- (c) the new address moves the voter to another county AFTER the books closed, the voter may go to their former county of residence, vote one election, and sign the Precinct Roster. The voter should complete a new Voter Registration Card for the new county of residence. [(KRS 116.025(5)]
- (d) the new address moves the voter to another county BEFORE the books closed, the voter is not eligible to vote in either county.
