

### EARLY VOTING & ELECTION DAY SUMMARY QUESTIONS:

### 1) Why is the consolidation of these precincts desirable?

The consolidation of precincts into vote centers creates an efficient Election Day process. It allows staff from the clerk's office to be at every location to monitor and assist officers with election duties. We need fewer poll workers, which allows us to be more selective and allows us to use more experienced, qualified election officers. As we did in 2020, we are able to reassess location needs and create additional job roles to streamline the voting process. This, combined with the use of ePollbooks, results in shorter wait times for voters. Reducing our locations from 49 to 8 will allow us to set up all equipment and other supplies prior to Election Day. This makes election morning much less chaotic for poll workers & provides consistency across all 8 locations.

### 2) In what manner will Precinct Officers be assigned?

We will ensure parity among all poll workers across all locations. Election officers will be placed according to the precinct they are registered in. Each location will be fully staffed according to estimated turnout per day.

## 3) How will the voting location be publicized to voters? How will the location be noted as a "Vote Center"?

We will send postcards to every registered voter in the county notifying them of their Election Day location options, as well as early voting plans. We will also put several notices in the local newspaper, and post notice on our clerk website and county social media.

During early voting we will have large signs posted identifying each location as a County-wide Early Voting location. On Election Day we will have large signs posted at each location identifying the location as a County-wide Vote Center. We will also assist voters in finding the vote center most convenient to their precinct.

# 4) How will the voting location serve as a focal point to meet the needs of a diverse community?

The creation of county-wide vote centers for early voting allows our voters to pick from FIVE (5) locations for the three days of early voting. Our Living Hope location is conveniently located close to the center of town near our commercial district. Our Sugar Maple location is close to downtown & is on a BG Transit public transportation route, making it accessible for those within the city limits who need transportation to a polling location. Our other three locations are park locations on the outskirts of the city limits, making it more convenient for rural voters who travel into the city for work and errands.

For Election Day, we will have EIGHT (8) County-wide vote centers. We chose our vote centers with travel time in mind. The attached map shows the location of each of the vote centers. Each location was strategically chosen for its substantial square footage, ample parking, and adequate ADA accessibility for voters with disabilities. We also chose several locations on the outskirts of town to add convenience for our rural voters. County-wide vote centers will enhance voting in our county by giving voters multiple location options for casting their ballot.
